NCACCH is an Aboriginal Community Controlled Health Organisation (ACCHO) delivering services to the Sunshine Coast and Gympie regions through a unique Brokerage Model. Funded through Department of Health, Qld Government and Central Queensland, Wide Bay, Sunshine Coast PHN, we offer primary health care services, chronic disease, health promotion activities and cultural connectedness events.

NCACCH has a vision to “Close the Gap” in the health status of Aboriginal and Torres Strait Islander people through a holistic approach to client health and wellbeing.

NCACCH Board

NCACCH Board of Directors have a passion and commitment to support strategies in Closing The Gap and improving health inequalities for our people.

The NCACCH Board comprises of seven (7) Directors and hold 10 Board meetings per year, as well as conducting a minimum of one (1) strategic workshop per year.

Director Role

The role of the Directors is to provide leadership, direction and oversight to the organisation. The Director’s charter encompasses three major elements:

- A legal dimension; requirement to conform to relevant laws and regulations
- An ethical dimension; requirement to demonstrate a high level of responsibility not only to members and employees but also to clients, service providers, and to the community at large
- A business dimension; requirement to ensure that the organisation plans effectively for sustainability, progress, advancement, best practice and continuous development whilst continually monitoring its stated goals

Remuneration

The role is voluntary. Travel and/or accommodation expenses for attendance at Board Meetings and any other reasonable expenses incurred in carrying out the duties of a Director are paid by NCACCH.

NCACCH invites interest from Aboriginal and Torres Strait Islander community members, **who are current financial members**, with the following qualities:

- Experience and/or understanding in effective Governance
- Experience and/or understanding of risk management
- Experience and/or understanding of strategic management

NCACCH is willing to support the right candidate to access the required Professional Development to meet the above qualities.

It is highly desirable for potential Directors to have an understanding of contemporary health systems and emerging directions in Aboriginal and Torres Strait Islander health. Established stakeholder networks and links to the Sunshine Coast and/or Gympie Aboriginal and Torres community are a must.
