#### NCACCH Background Statement

North Coast Aboriginal Corporation for Community Health (NCACCH) is a not for profit, Aboriginal Community Controlled Health Organisation and is funded by the Australian Government's Department of Health (DoH), Central Queensland, Wide Bay & Sunshine Coast PHN and the Queensland Government Department of Health.

NCACCH is an innovative leader in Aboriginal and Torres Strait Islander healthcare, providing a range of services and programs through its hybrid Brokerage and Aboriginal Medical Service (AMS) model for health service delivery. NCACCH maintains contracts with over 800 primary and allied health professionals across the region.

With the purpose of providing a holistic and comprehensive primary health care service, NCACCH seeks to improve health and social outcomes to our community through:

- Provision of access to a full regional network of health care professionals
- Encouraging choice for Aboriginal and Torres Strait Islander community members and their families. And through exercising this choice, building cultural sensitivity and inclusiveness across the community while simultaneously promoting market competition between health care service providers; and
- Utilising its Aboriginal Medical Service and partnerships with primary healthcare and other specialised services, as a proactive strategy in delivering community wide "Closing the Gap" health status improvement initiatives

### **Purpose of the Position**

The position is responsible for specialist community and primary health nursing services that focus on the prevention, early detection and management of health challenges for Aboriginal and Torres Strait Islander people. As a member of a multi-disciplinary team, ensure effective screening, service delivery and administration practices are delivered in accordance with NCACCHs Model of Care. The role will entail service delivery from designated primary clinic location/s and/or outreach services, under limited supervision, as required.

The NCACCH Clinical Nurse is expected to operate with the highest level of integrity, accountability and professionalism in accordance with NCACCHs values and Code of Conduct. In addition, this position works closely with the Practice Manager to ensure NCACCHs business objectives are met through robust and effective support systems and activities to support continuous improvement through encouraging innovation and best practice, within NCACCHs current quality management systems.

### **Selection Criteria**

#### **Essential:**

- Demonstrated clinic-based experience within an Aboriginal and Torres Strait Islander Community Controlled Health Service (ACCHO) or similar
- Demonstrated ability to implement and support a medical/primary health care team and effectively plan and coordinate own and teams workload to achieve results
- Demonstrated ability to communicate and empathise with Aboriginal and Torres Strait Islander people
- Demonstrated experience in leading/working within a multidisciplinary team environment, including the ability to demonstrate exceptional clinical skillsets
- Demonstrated high-level computer skills, web-based programs and applications including Microsoft Office Suite and aptitude to learn other relevant software systems
- Strong administrative skills including the ability to prioritise competing work priorities, maintain accurate and legible records and meet targets and performance outcomes
- Strong interpersonal and communication skills with a focus on patient outcomes; including the ability to develop meaningful relationships whilst respecting traditional culture and values
- Demonstrated highly developed written and verbal communication skills with the ability to liaise with patients, internal and external stakeholders

### Summary of Duties

In accordance with the relevant policies of NCACCH, the procedures developed under these policies, program guidelines and subject to directions of the Practice Manager, the Clinical Nurse is responsible for specialist community and primary health nursing services that focuses on the prevention, early detection and management of health challenges with the aim of improving the health and wellbeing of Aboriginal and Torres Strait Islander people.

In co-operation with and subject to direction of the Practice Manager the Clinical Nurse shall carry out the following duties:

#### **Service Provision: within the clinic/program approved annual action plan;**

- Provide day to day health service activities to the Gympie and surrounds within the context of Primary Health Care in a professional, confidential and culturally safe manner
- Provide culturally effective first point of medical engagement including, triage assessments, taking of medical history/detail/s
- Provide routine screening services to patients including blood pressures, blood sugar levels, temperatures including the appropriate reporting and recording requirements
- Perform best practice service delivery within scope of practice, observing universal precautions and follow standing orders / guidelines in the absence of a Medical Officer
- Provide treatment and care to all patient's under the direction of the GP, including immunization of all babies, children & adults in line with the Australian Immunization Handbook including the appropriate reporting and recording requirements
- Conduct comprehensive Child and Adult Health checks in line with NCACCH policy and procedures and national guideline recommendations
- Provide wound care and assessment
- Liaise and coordinate treatment, care and follow up through consultation with other visiting allied health/specialists, hospitals and agencies
- Attend to home visits with GP if required
- Primary responsibility for monitoring and ensuring maintenance of cold chain systems and other medical storage systems & clinical equipment
- Primary responsibility for implementing and overseeing a system for monitoring and educating of infection control processes including compliance with cleaning procedures
- Provide ongoing health education and promotion on a one-to-one basis to all the services patients
- Coordinate and initiate patient referrals, internally and externally, for specialist care in conjunction with Medical Officer
- Maintain treatment/consulting room stock control and assist with preparation of procedures and clean up
- Use equipment as per procedures, report any functional problems, maintain sterilization procedures

- Check and audit the emergency trolley each day to ensure all equipment is working, including the restocking of emergency drugs
- Comply with Clinic Procedures Manual in the delivery of services
- Provide periodic performance and evaluation reports to the Practice Manager as required

#### **Medications;**

- Under limited supervision store, prepare and administer medication in accordance with unit policy, protocol and relevant legislation
- Instruct and educate patient/care givers on how to take medication, the correct dosage, storage and security
- Instruct patient/care givers on how to obtain new medication supplies when required and initiate and advocate for access to CTG through patient local pharmacy
- Complete stock-take of medications which includes, but not limited to; ordering, expiration dates and disposal
- Maintain accurate records of medications and management of policy and procedures that reflect current best practice and legislations

#### **Data Administration:**

- Maximise Medicare Billings/claims through effective and timely clinic and patient records processes
- Accurately document patient files with treatment and medication information
- Ensure maintenance and confidentiality of patient health records
- Maintain accurate patient records, including the collection and collation of statistical information in order to forecast demand for services and allocation of budgets
- Ensure and maintain recall system and follow up register for patients

#### **Relationship Management;**

- Foster productive working relationships with other NCACCH staff in the delivery of seamless support services
- Actively foster productive working relationships with local networks, government departments, other service providers and suppliers to promote NCACCH and remain abreast of emerging issues
- Encourage cross-functional collaboration to achieve the best outcome for the organisation and community

#### **Information Management;**

- Undertake reporting activities together with other relevant documentation within the scope of your role
- Maintain the information flow that supports reliable data and documentation in your area of responsibility
